(a) The corporation shall be carried on without purpose of gain for its members, and any profits or other accretions to the corporation shall be used in promoting the corporation's purposes.
(b) The corporation shall have two (2) classes of members, namely:
(i) Registrant Members, which shall be issued membership in the corporation in accordance with the provisions of the corporation's by-laws. Each Registrant Member shall be entitled to one (1) vote for each registration held as provided for in the corporation's by-laws; and
(ii) Director Members, who shall be members in the corporation in accordance with the provisions of the corporation's by-laws. Each Director Member shall be entitled to one (1) vote as provided for in the corporation's by-laws.
(c) Commercial purposes, if any, included in the articles are intended only to advance or support one or more of the non-profit purposes of the corporation. No part of a corporation's profits or of its property or accretions to the value of the property may be distributed, directly or indirectly, to a member, a director or an officer of the corporation except in furtherance of its activities.
(d) Upon the winding up or dissolution of the corporation or the surrender of its charter or other termination, any assets of the corporation remaining after the satisfaction of its debts and liabilities shall be distributed, upon the confirmatory vote of a majority of the board of directors:
i. to any organization with objects similar to those of the corporation failing which they shall be distributed
ii. to such person or persons as is or are identified by the board of directors in its absolute discretion,
provided in both cases that the recipient shall operate solely in Ontario.
